2) Public Comment

a) No members of the public present.

3) Approval of Minutes | Action Required

a) Robert Hunter made a motion to approve the minutes; motion seconded by Keith Hutchings. Motion passed.

4) Report from Department of Public Works

a) Christina Peltier provided a comprehensive overview of recent highlights in the complete streets department including the Safe Streets for All (SS4A) award, RAISE grant, and application for the City of Detroit to host the 2026 NACTO conference.

5) Report from Transit Agencies

- a) RTA: Ben Stupka reported that as of October 1st, 2024 the RTA has begun Q Line operations. Additionally, ridership has increased in the D2A2 and DAX services. The RTA is initiating an Access to Transit grant program (funded via CMAQ) to improve bike and pedestrian facilities around bus stops. Lastly, beginning work on the federally mandated Coordinated Human Services Transportation Program, aka *Mobility for All*, be on the lookout for a call for projects in the next couple of months.
- b) DDOT: Riki Yamakura reported that the Coolidge project is progressing toward an opening date in the first quarter of 2026. Jefferson BRT project implementation is undergoing procurement and construction will begin in 2025. Public and stakeholder comment for Rosa Parks is on the horizon.

6) Amend Detroit FAC Bylaws | Action Required

- a) Chair Johnson presented the proposed revision to the committee bylaws including omitting the Q-Line representative, as the RTA now holds that vote.
- b) Riki Yamakura made a motion to approve the bylaws as amended; motion seconded by Ben Stupka. Motion passed.

a) Dara O'Byrne reported that the City of Detroit is updating the Master Plan. Policy development beginning early 2025, anticipating adoption in first or second quarter of 2026.
