Limits	Project boundaries.
Length	Project length (miles).
Primary Work Type	The type of work that will take place.
Project Description	Description of the project.
Phase	Projects contain one or more phases, work that has to be done at different points in the project's implementation process (see table 2 for the project phase key).
Fed Estimated Amount	The amount of federal-aid funding programmed for that phase of the project.

ROW	Right-of-Way. Purchase of real property (land and structures) that must be removed in order to implement a project.
SCOP	Scoping. Activities to define the functional parameters of a particular project, including site assessment, studies, and early cost estimates.
