SEMCOG, the Southeast Michigan Council of Governments, is committed to providing information and opportunities to engage with its plans and programs and other quality-of-life issues that impact Southeast Michigan residents.

We provide forums and make presentations to local governments and stakeholder groups to ensure community views are heard on planning and project-related issues. We encourage public participation in the development of SEMCOG plans and programs and any substantive amendments to them.

The CAC is working to take our public engagement efforts a step further by helping educate residents on the transportation planning processes in their communities and to elevate local perspectives to guide our regional decision-makers.

The goal of the Civic Advisory Committee is to facilitate meaningful and intentional public involvement—particularly around transportation and mobility—in Southeast Michigan. The CAC will:

- Feature representation from interest groups and/or individuals throughout the seven-county Southeast Michigan region
- Provide education and engagement on key regional planning initiatives related to transportation and mobility
- Work in coordination with the Regional Transit Authority's Citizens Advisory Committee and other regional engagement efforts
- Report to SEMCOG's Transportation Coordinating Council (TCC)
- Provide opportunities to build consensus and record and report perspectives/comments from CAC to TCC and appropriate task force, committee, or the agency responsible for the work or issue area
- Report to CAC committee members on delivery of comments and response from TCC and relevant agencies, if applicable
